SERVICE CONDITIONS FOR EMPLOYEES :

1. A Teacher's appointment is confirmed and made permanent twelve months after the date of appointment.
 2. A permanent employee can avail 1 day's casual leave each month. This can also be saved and encashed at the end of the Academic year.
 3. An employee under probation can avail of 1 day's casual leave each month but this cannot be encashed at the end of the Academic year
 4. Permanent female employees are entitled to avail of 3 months paid maternity leave. Any extension will be on loss of pay
 5. An employee under probation can be made permanent only if he / she meets the performance criteria expected.
- During probation the employees will be paid a consolidated salary
- On confirmation of employment at the end of twelve months, the employee will be included in the PF scheme and his / her salary will be disbursed through a bank account.
- All appointment to all categories of employees shall be made by the managing committee or its authorized representatives.
- Employees shall have to comply with all the requirements of the service contract.
10. Every employee shall be required to produce the following certificates on appointment in the school.
 - i) Medical Certificate
 - ii) Character and Conduct Certificate
 - iii) Original degree and diploma certificate. The same will be returned to the candidate after verification. The school will retain the attested photocopies.
 11. If an employee intends to resign at any time after confirmation, he / she shall give three month's notice in writing or three months salary including all allowances to the managing committee.
 12. Every employee including the Head of Institution shall retire from service at the age of 60.
 13. An employee is also required to conduct and organize co - curricular programmes and perform other duties even beyond the normal working hours.
 14. Every teacher shall devote in a year not less than 1200 hours to the teaching of students.
 15. Teachers shouldn't use cell phone in the school.
 16. No member of the staff shall apply for employment elsewhere without notifying through the principal in writing to the management.
 17. No staff member shall undertake private or any other tuition.

DISCIPLINARY PROCEDURE :

18. He / She is charged with cruelty / physical punishment or mental harassment towards any student or any employee of the school.
 19. He / She is charged with misbehaviour towards any parent, guardian student or employee of the school.
 20. A case against him / her in respect of any criminal offence is under investigation or trail.
